1. BACKGROUND:

The Chhoiling Chhorten Gumba and Chyang Chhoya Ganga Bayakhelne Chulidanda are significant cultural, religious, and tourism landmarks located in the Shailung-2 area of Shailung Rural Municipality. These sites hold immense value for the local community and the broader cultural landscape, attracting visitors for their religious importance and natural beauty. They also have the potential to become key tourist destinations, contributing to the socio-economic development of the region.

The proposed project aims to **enhance the infrastructure**, **improve accessibility**, and ensure the **sustainability** of these sites. Draft Report (2 copies)

The consultant shall submit the **Draft Report**, which shall consist of the design details, including architectural drawings, site plans, elevations, landscaping designs, and utility layouts, as well as the **cost estimation** covering construction, materials, labor, and other project expenses. This shall be submitted within **25 days** from the date of the work order.

Final Report (3 copies)

The consultant shall submit the **Final Report**, which shall include the finalized **Conceptual Plan**, **technical drawings**, and **cost estimation**, along with any revisions or updates based on feedback from the Draft Report. The final report shall also include a comprehensive summary of the project's scope, feasibility, and implementation plan. This shall be submitted within **30 days** from the date of the work order.
